IN 2015, THESE EDUCATIONAL PRODUCTS INCLUDE THE ONLINE CODE EDITOR THIMBLE, THE ANDROID APP WEBMAKER, AND A SLATE OF INTERACTIVE TEACHING ACTIVITIES THAT FOCUS ON SUBJECTS LIKE ONLINE PRIVACY AND CODING.
